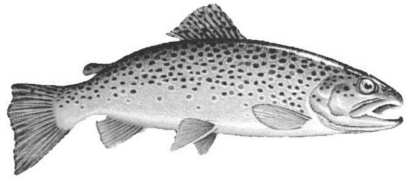

# Hendrickson Hatch Catch & Release Fly Fishing

**Rules:** Fishing will take place on the Salmon River between the Chasm Falls dam and State Route 37 in Westville, NY. A map of the Salmon River will be given to each participant for a reference. Access to the river must be public and legal. Please respect all posted and private property. Fishing licenses are required for ages 16 and up.

**Start of Fishing:** Anglers will meet at the Malone Campus of North Country Community College between 8:00 am and 9:30 am on Saturday morning for tournament registration. Pre-registration is suggested as participation will be limited to 75 anglers. Between 9:30 am & 10:00 am rules will be reviewed and anglers will be paired with partners. Fishing begins at 10:00 am.

**Sportsmanship:** This tournament is about celebrating the great outdoor experiences available in northern Franklin County. Participants are asked to be courteous of other anglers and maintain the spirit of good sportsmanship.

**Scoring:** Anglers must fish with a partner. Anglers will record the total number of fish caught, the length of each fish and cumulative number of inches. Only fish handled by the angler and successfully released count as being caught. Fish under 12", foul hooked fish, and dead fish do not count. Tabulate and record each fish, and at the end of the time period, count the total number of inches and turn the score card into the official judge for scoring. *Score cards must be turned in by 1:00 pm on Sunday.*

**Awards:** Plaques will be awarded to the top three winning anglers based on the total number of inches accumulated. A plaque will also be awarded to the angler with the largest trout landed and released. All registered anglers will be entered in a drawing for the chance to win miscellaneous door prizes.

**Tournament Organization:** Great appreciation to Brookfield Power for sponsoring this annual event. All proceeds from this tournament go to the Malone Revitalization Foundation for continued enhancement of the community. Members of the Hendrickson Hatch organizational committee welcome input on ways to enhance fishing on the Salmon River.
